

RESOLUTION NO. 2016-09

A RESOLUTION OF THE CITY OF OAK RIDGE NORTH, TEXAS, SETTING A SERVICE TERM FOR CAPITAL IMPROVEMENT ADVISORY COMMITTEE MEMBER RICHARD OTWELL; PROVIDING FOR SEVERABILITY; AND PROVIDING FOR AN EFFECTIVE DATE.

WHEREAS, the City Council of the City of Oak Ridge North, Texas, ("City Council") passed Resolution 2016-02 on April 25, 2016, creating the Capital Improvement Advisory Committee and appointing its members pursuant to Texas Local Government Code Chapter 395; and

WHEREAS, City Council appointed the Planning and Zoning Commission and Richard Otwell, as a representative of the City's extraterritorial jurisdiction, to serve as the Capital Improvement Advisory Committee; and

WHEREAS, the service terms for those members of the Capital Improvement Advisory Committee who also serve as the Planning and Zoning Commission coincides with their existing service terms for the Planning and Zoning Commission; and

WHEREAS, City Council now desires to set a service term for Capital Improvement Advisory Committee member Richard Otwell; and

NOW, THEREFORE, BE IT RESOLVED BY THE CITY COUNCIL OF THE CITY OF OAK RIDGE NORTH, TEXAS:

Section 1. The findings and recitations set out in the preamble to this Resolution are found to be true and correct and are hereby adopted by the City Council and made a part hereof for all purposes.

Section 2. The City Council hereby establishes the service term of two (2) years for Richard Otwell as a member of the Capital Improvement Advisory Committee beginning from the date of his appointment to the Capital Improvement Advisory Committee by Resolution 2016-02 adopted on April 25, 2016.

Section 4. Severability. In the event any clause, phrase, provision, sentence or part of this Resolution or the application of the same to any person or circumstances shall for any reason be adjudged invalid or held unconstitutional by a court of competent jurisdiction, it shall not affect, impair, or invalidate this Resolution as a whole or any part or provision hereof other than the part declared to be invalid or unconstitutional; and the City Council of the City of Oak Ridge North, Texas, declares that it would have passed each and every part of the same notwithstanding the omission of any part thus declared to be invalid or unconstitutional, or whether there be one or more parts.

Section 5. Effective Date. This Resolution shall be effective upon its passage and approval by City Council.
