



Irrigation Permit Application

All irrigation systems must comply with City of Oak Ridge North Code of Ordinances and TCEQ standards. If a new water taps is required, please include the [water and sewer tap application](#). Any addition or alteration to an existing irrigation system requires a permit. All irrigators must be registered with Oak Ridge North before any work requiring a permit can be done. Permit fees are as follows.

- Residential Irrigation - \$115.00
- Commercial Irrigation - \$115.00 for the first 10,000 square feet and \$6.00 for each additional 2,000 square feet of area to be irrigated.
- Contractor Registration - \$100.00

Please complete and submit the application and all necessary accompanying forms by email to permits@oakridgenorth.com or deliver digital PDF to the permit office located in City Hall at the address located at the bottom of this page. **Submitting an incomplete application will result in the application being denied.** The applicant will receive the City’s written comments, and notification of any additional requirements, within 10 business days.
