



SIGN CONSTRUCTION PERMIT APPLICATION

All signs must comply with City of Oak Ridge North Code of Ordinances (Chapter 14 and 62). One PDF digital copy of the plans and all supporting documents, must accompany the application.

The sign permit fees are determined by the type of sign. Permit fees are listed in Oak Ridge North Schedule of Fees.

Please complete and submit the application and all necessary accompanying forms by email to permits@oakridgenorth.com or deliver PDF to the permit office located in City Hall at the address located at the bottom of this page. **Submitting an incomplete application will result in the application being denied.** The applicant will receive the City's written comments, and notification of any additional requirements, within 15 business days.

- **WALL SIGNS SHALL NOT EXCEED 10% OF THE WALL AREA ON WHICH THEY ARE LOCATED AND LETTER SIZE SHALL NOT EXCEED 1.5 INCHES IN HEIGHT FOR EVERY FOOT OF BUILDING HEIGHT. TENANT SPACES LARGER THAN 10,000 SQUARE FEET ARE PERMITTED 2 INCHES IN HEIGHT FOR EVERY FOOT OF BUILDING HEIGHT.**
- **FREESTANDING SIGN INFORMATION CAN BE FOUND IN CHAPTER 62 OF THE OAK RIDGE NORTH CODE OF ORDINANCES.**
- **ALL INSPECTIONS MUST BE CALLED OR EMAILED IN 24 HOURS IN ADVANCE.**
