1. **POLICY:** The facility is available for use by the general public; however, reservations may be made by local civic groups or church groups without a minimum expected attendance limit to ensure availability. Any other individual or group will not be permitted unless the expected attendance exceeds fourteen (14) people. **Reservations will have priority.**
  2. **SCHEDULING:** Reservations for the facility will be scheduled during normal office hours. Reservations must be made at least ten (10) days prior to the scheduled activity. An adult (18 years of age or older) must sign for a reservation.
  3. **TIMES:** The facility may be reserved between the hours of 8:00 a.m. to 10:00 p.m. with a four (4) hour maximum. City Council approve reservation requests for hours outside of those specified above much.
  4. **FEES:** \$10.00 per hour, unless otherwise noted
  5. **REFUNDS:** Usage fees are **NON REFUNDABLE.**
  6. **GARBAGE:** Garbage or trash should be bagged and may be placed in the dumpster. **DO NOT USE THE PARK CANS.** Garbage bags and clean-up crews are not furnished.
  7. **DAMAGES:** Please report any damages to the Police Department (281) 292-4643 for the safety of the park patrons.
  8. **ALCOHOL:** No alcohol beverages are permitted on park premises, which is enforced by City Ordinance.
  9. **CONCESSIONS:** Concessions will not be permitted unless authorized by a city official.
  10. **PUBLIC ADDRESS SYSTEMS:** Loud speakers are permissible when authorized by a city official.
  11. **ABUSE:** Facility abuse or non-compliance with any one or more of these rules stated in this document could result in indefinite suspension of the individual, group or organization from future use. If abuse is judged by a City Representative, **all damage repairs will be the responsibility of the individual who reserved the facility.**

**Release of Waiver**  
**CITY OF OAK RIDGE NORTH, TEXAS**

In consideration of being allowed to utilize the facilities, services, parks and programs of the City of Oak Ridge North for any purpose, including, but not limited to observation or use of facilities, parks or equipment, or participation in programs affiliated with the facilities, services or parks, the undersigned, for himself or herself or company and any personal representatives, heirs, next of kin, or officers and employees of such company, hereby acknowledges, agrees and represents that he/she has, or immediately upon entering or participating will, inspect and carefully consider such premises and facilities or the affiliated program. It is further warranted that such entry into the facility for observation or use of any facilities, parks or equipment, or participation in such affiliated program constitutes an acknowledgement that the undersigned has inspected such premises and all facilities and equipment thereon, any such affiliated program has been carefully considered, and that the undersigned finds and accepts same as being safe and reasonably suited for the purpose of such observation, use or participation by the undersigned.

The undersigned is aware of the different types of activities, equipment, and facilities offered by the City of Oak Ridge North, and is aware of the risks inherent in the participation in such activities and use of such equipment, parks, and facilities.

In further consideration of being permitted to enter the facility for any purpose including, but not limited to observation or use of facilities, parks or equipment, or participation in any program, the undersigned hereby agrees to the following:

1. The undersigned on his or her behalf and, if applicable, on behalf of the company, hereby releases, waives, discharges and covenants not to sue the City of Oak Ridge North, its officials, officers, employees, or agents (hereinafter referred to as "Releasees") from all liability to the undersigned and any personal representatives, assigns, heirs, and next of kin, or officers and employees of such company, for any loss or damage, and any claim or demands therefor on account of injury to the person or property, including injury resulting in death of the undersigned whether caused by the negligence of the Releasees or otherwise while the undersigned is in, upon, or about the premises, facilities, or equipment therein or participating in any program affiliated with the City of Oak Ridge North.
2. The undersigned hereby agrees to indemnify and save and hold harmless the Releasees and each of them from any, loss, liability, damage or cost Releasees may incur due to the presence of the undersigned upon or about the premises or in any way observing or using any facilities or equipment of the City of Oak Ridge North or participating in any program, whether caused by the negligence of the Releasees or otherwise.

The undersigned hereby assumes full responsibility for and risk of bodily injury, death, or property damage to the undersigned due to negligence of Releasees or otherwise while in, about or upon the premises while using the premises or any facilities or equipment thereon or participating in any program affiliated with the City of Oak Ridge North.

The undersigned further expressly agrees that the foregoing Waiver and Release is intended to be as broad and inclusive as is permitted by the laws of the State of Texas and that if any portion thereof is held invalid, it is agreed that the balance shall, notwithstanding, continue in full legal force and effect.

The undersigned has read and voluntarily signs the Waiver and Release, and further agrees that no oral representations, statements, or inducement apart from the foregoing written agreement have been made.
